1. Rationale

Oakleigh Grammaris committed to protecting the privacy of individuals.

The schooltherefore support and endorse the Australian PrivacyPrinciples("APPs") contained in the Privacy Act 1988 (Cth) ("the Privacy Act") and will only collect, use, disclose, manage and store personal information in accordance with these

Personal/information means information or an opinion about an identified individual, or an individual who is reasonably identifiable:

whether the information or opinion is true or not; and whether the information or opinion is recorded in a material form or not.

In the course of providing services we may collect and hold personal information including names, addresses and other contact details; dates of birth; next of kin details; photographic ID images; attendance records and financial information.

Sensitive information includes information or an opinion about an individual's:

5. What Kind of Information Does Oakleigh Grammar Collect?

The type of information that the school collects and holds (refer to all Definitions) will depend on the circumstances in which the school is collectingit.

As part of our recruitment processes for employees, contractors and volunteers, we may collect and hold personal information including name, address and other contact details, date of birth, financial information, citizenship, employment references, current employment information, directorships, media, photo id information, bank account details, driver's licence information, academic results and qualifications.

The school may also collect sensitive information from a person including health information.

A person is not required to provide the personal information and/or sensitive information requested by the school, however if a person chooses not to provide information as requested, this may influence the school's ability to service the person's needs. For instance, it will not be possible for the school to enrol a person or provide education to the person if the person wishes to remain anonymous or use a pseudonym.

6. How Does Oakleigh Gram mar Collect Personal Information? The collection of personal information depends on the circumstances in which Oakleigh Grammar is collecting it. The school will generally collect personal information directly from the owner of the personal information.

9. Disclosure of Persona I Information Overseas

Otherwise, the school may disclose personal information to a recipient overseasin accordance with the Privacy Act where:

the owner of the personal information has consented to the disclosure; we reasonably believe that the overseasrecipient is subject to a law or binding scheme that protects the information in a way that is substantially similar to the way the information is protected under the PrivacyAct and the APPs;

we form the opinion that the disclosure will lessen or prevent a serious threat to the life, health or safety of an individual or to public safety; or the disclosure is required or authorised by an Australian law or a court order.

10. Direct Marketing
